Vedanta subsidiary TSPL sets world record by planting 2 lakh saplings in 1 hour!

Mansa, Punjab, October 30, 2015: Talwandi Sabo Power Limited (TSPL) in Punjab, a subsidiary of Vedanta Limited today attempted to create the world record for planting 2 lakh saplings within an hour. Over 5,800 supporters from schools, surrounding villages and locals volunteered to make this feat possible. TSPL will apply to the 'The Guinness Book of World Records' to feature as the record holder for the highest number of plantations within an hour. With this massive plantation drive, TSPL has achieved more than the previous record of 100,450 plantations within one hour, which is held by 'Men of the Trees', at the Whiteman Park, in Perth, Australia. The plantation began at 11.35 am, and within less than an hour, by 12.27 pm, 2,06000 saplings were planted on 200 acres land. Considering the small forest cover in Punjab, these additional trees will help improve the biodiversity in the region and specifically in Mansa.

"TSPL is deeply committed to the sustainable economic development of the progressive state of Punjab. This massive plantation drive is not only a symbol of our deep connect with the state but also a personification of our motive to make it one of the most promising regions globally. With a Guinness Book of World Records entry, the district of Mansa and the state of Punjab will become even more prominent across the world", said Mr. Philip Chacko, COO, TSPL, adding that, "Today the people of Punjab have tried to beat the existing record made in Australia. We had taken a target of 2 lac saplings."

TSPL has set the benchmark for environmental compliance by developing 222 acres of green cover (as of March 2015) around the periphery of the plant and installing Zero Discharge Unit, Sewage Treatment Plant and High Concentration Slurry Disposal (HCSD) system.
